

PURCHASING CHECKLIST

- Get pre-approval from the bank to know how much you can borrow
- Negotiate with the selling agent a purchase price.
- Engage Christolynn Conveyancing Services to help with all the legal work
- Complete our Purchasers initial information sheet and sign the agreement
- Arrange a building and pest inspection of the property or have Christolynn Conveyancing Services arrange these on your behalf.
- Christolynn Conveyancing Services will then review the contract and negotiate any changes you require to the Contract.
